PURPOSE:

The Mercer County Prosecutor's Office is committed to providing quality law enforcement services for the County of Mercer. In accord with Public Law 2020, c.107, and in compliance with New Jersey Attorney General Guidelines "Promoting Diversity in Law Enforcement Recruiting and Hiring," issued December 7, 2021. Prosecutor Onofri and Chief Plumeri strive to recruit the most qualified candidates for openings within the agency that are diverse and representative of the population of Mercer County.
